Former Milford village clerk indicted by grand jury, faces theft, forgery charges

WATSEKA—Milford's former village clerk was indicted by an Iroquois County grand jury Thursday on charges stemming from the theft of \$14,000 from the village.

Susan Ricketts, 39, of Milford, was indicted for theft of more than \$10,000, three counts of official misconduct, two counts of forgery and financial exploitation of an elderly person. She was arrested Thursday and released on bond.

Ricketts was fired from her position as clerk in April. The firing was approved by the village board following an investigation by the Illinois State Police that turned up missing money in village utility funds.

In January, village auditors informed the board of a discrepancy of more than \$14,000 between receipts and deposits. Ricketts was the person primarily responsible for collecting utility bills and making deposits.

She is further charged in connection with money misappropriated from the bank account of a 65-yearold Milford man for whom she acted as power of attorney.

The indictment alleges the criminal actions occurred between May 2000 and February 2002.

The most serious of the charges are theft and financial exploitation of an elderly person, both Class 2 felonies. Penalties range from probation to three to seven years in prison. Official misconduct and forgery are Class 3 felonies punishable by probation to two to five years in prison.

Ricketts had been the village clerk for approximately 15 years.

She is scheduled to appear in court next on June 10.
