Jamesburg bicyclist is now victim in murder investigation

A Jamesburg man whom police thought died as the result of a hit-and-run car/bicycle accident was shot before he was hit by a vehicle.

Pathology reports showed Michael Fink, 20, was fatally shot before he was hit by a car on Jamesburg Road early Friday morning.

Vermilion County Sheriff's Police arrested a man they allege struck Mr. Fink with a vehicle. Charles Burrows, 42, of rural Danville, was being held on charges of leaving the scene of a personal injury accident and obstructing justice. Obstruction charges may also be filed against two unidentified passengers who were with Burrows at the time.

No charges have been filed in connection with the shooting.

Lack of interest changes date for Hoopeston Hoops tourney

The date for the third annual Hoopeston Hoops three-on-three basketball tournament has been moved to Sept. 21 after organizers received no registrations for the original July 27 date.

Registration packets were sent to past participants, none of whom responded, said Susan Redden, community fund secretary.

Organizers hope delaying the date will result in more interest in the community fund's second-largest fundraiser.

an anonymous call at about 3 a.m. Friday. The caller reported a body lying along Jamesburg Road east of Jamesburg. Mr. Fink was found on the south side of the road and the bicycle on the north side.

Because of severe trauma to Mr. Fink, police requested an autopsy which showed the gunshot wound.

The car used in the hit-and-run accident was found Sunday, hidden in a wooded area on the north edge of Danville.

According to reports, Burrows hit the bicycle, then hit Mr. Fink. One of the passengers reportedly drove the car from the scene while the other passenger made the call from a payphone to the sheriff's department.

Burrows turned himself in to police Monday and is awaiting filing of formal charges by the state's attorney's office.

The tournament will be divided into male and female age divisions of 10 and under; 11-12; 13-14; 15-16; 17-19; 26-35; and over 35.


Each team may include three players and one alternate, with an entry fee of \$20 per player. All games will be played in downtown Hoopeston.
