## Milford village board rejects settlement offer in law suit

MILFORD—An alleged breach of contract with a former gas supplier has the Milford Village Board steaming.

According to the Milford Area Bulletin Board, the board, at a special meeting Saturday, rejected a \$310,000 settlement offer from Duke Energy of Texas to end the company's suit against the village.

The suit was filed after Milford notified the company in July 2001 that it would no longer buy their gas. The company claimed a \$500,000 loss and filed suit.

Milford signed a three-year contract with Duke in 2001 when the company offered a slightly lower gas rate than what the village had been paying. Officials opted to sign with Duke to provide stability in what was then a volatile gas market. However, village officials allege

Duke over-injected village reserves when the price was high and did not bill the village properly, resulting in monthly negotiations between the two. In the fall of 2001, officials felt the problems with the company constituted breach of contract and signed with CMS, another Texas firm.

Negotiations hit a stalemate last week when village attorney Jim Kinzer offered to settle for \$75,000 and Duke's attorney started at \$425,000.

The case is set to be heard in a Texas court so the village, on Kinzer's recommendation, has hired a Texas law firm to represent it.

The board did approve paying Duke \$63,551.91 for over-injections the company made but had never billed the village.
