

### Candidate for Illinois Supreme Court visits Hoopeston

Justice Sue Myerscough hopes to bring honesty, integrity and fair play to the Illinois Supreme Court.

The Justice was in Hoopeston last Thursday meeting with fellow Democrats and media representatives.

Myerscough is running against Republican incumbent Rita Garman. "We've got two good candidates (for the Supreme Court)," Myerscough said. "That's the good news. Of course I hope people will vote for me."

She is currently a Fourth District Appellate Court Justice and has served as Chief Judge of the Seventh Judicial Circuit, both based in Springfield.

Family issues are among those most important to Myerscough, including. If elected, she will work towards a review of the state child support system, including enforcement, collection and disbursements.

As a Chief Judge, Myerscough computerized the Sangamon County courts, including child support payments. She criticized the state for sending collection of child support to Indiana after DuPage County bungled the job. "I think it needs to be done in-house," she said.

### New Baptist church to hold first service Sunday morning

AMBIA, Ind.—A new church in Ambia will hold its first service Sunday morning.

Tri-County Baptist Church, an independent Baptist Church, will hold its first services at 10 a.m. (CST), said Pastor Ernest Merritt.

The church is located in the former Ambia Christian Church at 316 S. Third St.

Merritt will hold a "get acquainted meeting" at 7 p.m. Thursday. The meeting is open to the public and will include Pizza Hut pizzas and Subway sandwiches.

Merritt hopes to reach people in Vermilion County, Ill. and Warran and Benton counties in Indiana. "Our main focus is reaching the lost for the Lord, Jesus Christ," he said. "We'll be an aggressive church searching for souls."

The new church does not intend to take members away from their own churches but to reach those who have no church home. Merritt said.

Merritt, who currently lives in Chicago, said he was led by God to start the church. The pastor at his church in Chicago lives near Boswell and one day Merritt was helping him with plumbing work. The two went to get parts, passing by the old church. Merritt, who was looking to become a senior pastor at an established church, felt guided to start a new congregation.

Church owners did not want to sell the building but later changed their minds. A \$9,000 price was agreed upon and Merritt's fellow congregants in Chicago raised money for a \$3,000 downpayment.

Tri-County Baptist will initially hold only Sunday morning services but plans include adding a 9 a.m. Sunday School and a Tuesday evening service in about a month.

Early next year, Merritt hopes to add a Sunday evening service, as well.
