Township building said sold

Unconfirmed reports indicate the deal to sell a Hoopeston building as a home for WitchSchool.com has been completed.

Neither seller/Realtor Larry Tobeck nor buyer Ed Hubbard of WitchSchool.com immediately returned phone calls seeking comment on whether the building, at 200 E. Penn, was sold.

However, other sources indicate they were contacted for comment on the closing by area media sources.

One of those was the Rev. Tim Kovalcik of the East Lynn United Methodist Church. "We believe the community is united," he said Monday. "We believe we're on the moral high ground," he said, adding the matter is now "in God's hands."

Last week, Hubbard said he would not locate the school in Hoopeston after hearing residents' complaints about the school. "I'm not going to go through with it," he said last Tuesday after a meeting at the Hoopeston City Building.

Previously, Hubbard had said the school expects to be open in September. WitchSchool currently accepts students for online courses. The building will be used for seminars and to house the school's shipping business, which includes books, incense and other items.

Editor's note: Just the Facts has received many emails concerning the proposed Witch School in Hoopeston. Due to space limitations, not all will be printed. Below is a random sample of letters received.



However, if they decide to go forward with it, it is their legal right, and you have no choice but to respect that as a private property transaction protected by law.

Should WitchSchool.com locate in Hoopeston, or elsewhere in central Illinois, you can be good neighbors.
