### Rossville trustees takes no action on naming TIF consultant

ROSSVILLE—A request from Mayor Terry Prillaman to name a new Tax Increment Financing consultant got no action at Monday's village board meeting.

Prillaman told the board that a new consultant needs to be hired because the previous consultant, Robert Vancil, has had no communication with the village. He suggested hiring Beth Ruyle of Ehlers & Associates of Lisle but the cost was a stumbling block for some board members.

In a proposal to the village, the firm quoted \$25,000 as the cost. However, Prillaman said, much of the work in the proposal is already done and he urged the board to consider instead the \$175 per hour fee with a maximum of \$2,000 per necessary report - instead. A consultant will be needed for things like agreements between the village and property owners and with builders.

"I can't see paying these prices," said trustee Mark Catron. "I think we need to find Mr. Vancil."

Prillaman said Vancil's contract expired last August, causing Trustee Robert Merritt to ask whether the board could put off a decision.

"It could be tabled but there are things that need to be acted upon," Prillaman answered.

#### Police News

A 19-vear-old Hoopeston man reported Tuesday that while he was walking his dog, someone broke an outside light bulb, scratched his car and knocked over his mailbox.

After failing to get a motion, Prillaman moved on to other business, saying he will ask Ruyle her fee as individual issues arise. "We'll take it one report at a time," he said.

In unrelated business, trustees discussed new regulations for arsenic levels in drinking water. According to the U.S. Environmental Protection Agency, the current standard of 50 parts per billion (ppb) must be reduced to 10 ppb by Jan. 1, 2006.

Rossville water has a rate of about 23 ppb and Trustee Mike Clutter said water has tested as low as 19 ppb. "We're better than half of what it used to be," he said.

To reach the new level, the village would have to install an iron removing system, which might or might not solve the problem. "We could spend close to half a million dollars to find out it doesn't work." Prillaman said.

Village officials do not expect to meet the Jan. 1 deadline and they hope the federal government will pay for the new mandate. "I think there'll be federal dollars available," Prillaman said, "There has to be. Otherwise, we can't do it."

In unrelated action, trustees:

- approved the final plat of the Thomas' First Addition and amended the Masengale Addition to allow for 10 foot front easements for AmerenCIPS to install electric service. AmerenCIPS will also charge to run power to each lot. The cost must be paid by the developer - in this case, the village - and will be equal to the total cost divided by the number of lots. The fee will be refunded as lots are developed. If all lots are developed within five years, the total cost will be refunded.
- approved Crowder CPA's bid of \$6,450-\$6,500 for the annual audit.
- heard a request from Mike Bray to eliminate
