Danville boy arrested in gun incident at Parkview Court

A 16-year-old Danville boy was arrested after he allegedly fired a gun at another man.

Police said the incident began at 9:47 p.m. Thursday at Parkview Court when a 29-year-old Hoopeston woman reported that several young men came to her home with several firearms. The woman left her home to get a 21-year-old Hoopeston man, brother to one of the intruders. After a verbal altercation, the 16-year-old allegedly fired at the 21-year-old an unknown number of times, then fled. The boy returned to the area about an hour later, when he was arrested.

Police said two firearms were recovered a few blocks from the area and that the guns match the descriptions of guns stolen earlier in the evening in Iroquois County.

The youth was charged with aggravated dis-

charge of a firearm, aggravated possession of a stolen firearm, unlawful use of a weapon and criminal damage to state-supported property. He was taken to the Juvenile Detention Facility in Danville to await a court appearance.

Police said no injuries occurred in the incident.
