## Hoopeston Community Memorial adds new radiology test

Hoopeston Community Memorial Hospital is offering a new, much needed service to Hoopeston and the surrounding communities.

Each Saturday a large white van and radiology technologist will be on site to perform magnetic resonance imaging (MRI) tests.

The van houses the very latest in Magnetic Resonance Technology - a special imaging tool which extends the capability to diagnose and treat injuries and illness.

The scans are performed by a radiology technologist with special training in this type of testing.

If a physician orders a radiology exam, including MRI studies, the radiology staff at Hoopeston Community Memorial Hospital has the ability to complete these studies. CT scans, Ultra Sounds, MRIs and general radiology studies are available at the facility.

MRI services can be scheduled for same week appointments and most other radiology services can be completed in the same day they are ordered.
