#### School board should bargain fairly

Hoopeston, already reeling from a long string of economic setbacks, now faces a wrenching new crisis. Negotiations between the school board and teachers have broken down due to intransigence to bargain in good faith by the Board. I am no longer directly involved in the process but the current impasse is essentially an extension of last year's bargaining and that was quite acrimonious and hostile towards teachers. Therefore, I feel fairly certain that the Board has little intent to bargain in good faith unless there is either a public outcry, a work action by the teachers' association, or both.

For many years, negotiations between the teachers and the Board were businesslike and relatively harmonious. Neither side ever got everything that they proposed but reasonable compromises were made without any long-lasting hostilities. Then, rather dramatically, the climate of the Board changed to the worse in regards to bargaining in a fair and fiscally responsible manner. It would appear that the Board no longer desires to invest in our community's



greatest asset--our children and their future.

It seems likely to me that the legacy of this Board will be that of infamy and disdain unless their obdurate intransigence mellows in regards to good faith bargaining. Failure to continue to invest in good teachers and educational programs is tantamount to condemning our students to a lower quality education. While a school district can find "warm bodies" to impersonate real teachers, those replacements will lack the warmth, competence, and compassion that the present staff displays every day on the job.

It is more than a little ironic to me that the long-time motto of our schools-- "Quality education with a small town touch" --is now emphatically threatened with the quality being sliced out in small surgical cuts.

I fervently hope that the current climate of bad feelings does not further erode into a permanent rift. Before

wounds get inflicted so deep that they can never heal properly, I would appeal for a shift in the Board's approach to allow fair bargaining to resume. The children are watching and deserve first consideration on all things.
