Hoopeston man sentenced to 30 years on murder conviction

DANVILLE—A Hoopeston man was sentenced Tuesday to 30 years in prison for killing another Hoopeston man.

Robert Akers, 28, was sentenced in connection with a May 22, 2005 incident in which he struck Larry Brougher in the head with a machete.

Akers was convicted on July 21 on four counts of first degree murder after jurors deliberated for about 90 minutes.

Akers was also sentenced to five years in prison on an escape charge. That sentence will be served concurrently with the murder sentence. Akers will get credit for 520 days of credit for the time he has

been in jail awaiting his trial and sentencing; however he will not be given credit for good behavior and must serve the entire sentence not covered by the credit for time served.

The minimum possible sentence was 20 years and the maximum was 60 years. An appeal was filed Wednes-

According to testimony at the trial, both Akers and Mr. Brougher were among those at a party at 321 W.

Penn. The group then went to 320 W. Maple, where the two got into a verbal argument about a stolen lawn ornament **-66** Mr. Brougher said was taken from his mother's yard. The fight turned physical and, according to testimony, was broken up by a third man when Akers took out a machete and struck Mr. Brougher. Akers left and, according to reports, went to 710 E. Wyman sometime after 10 p.m.

Akers was taken into custody and was secured in the back of a squad car while officers processed the scene when he escaped through a window. He was found the next evening in an abandoned car near

the former Wellington School by two men who put Akers in the back of a pickup truck and turned him over to police, still wearing handcuffs.

After the attack, Mr. Brougher was taken to Hoopeston Community Memorial Hospital, then airlifted to Carle Foundation Hospital, Urbana, in fair condition and was placed in intensive care immediately after the incident. He had reportedly been transferred from ICU because his condition had improved prior to his death.
