## Winter storm socks Hoopeston for second time in a week

For the second Tuesday in a row, Mother Nature dusted...with snow.

All area schools and some businesses were closed Tuesday after nearly four inches of snow had fallen by early morning. Schools were closed again Wednesday, after nearly eight inches of snow and high winds with gusts of as much as 40 miles per

The work day started early Tuesday for city crews as they plowed streets, only to have more snow fall and winds whip plowed snow back into Hoopeston's roads.

Police were kept busy, too, with calls for stuck vehicles and stranded motorists.

Wednesday saw partly cloudy skies with northwest winds at 15 miles per hour with gusts up to 20 miles per hour. Residents began the process of digging out Wednesday morning.

The snow is expected to be with us for a while as Thursday's forecast calls for cold temperatures with a high of 10 and a low of zero.

The National Weather Service is predicting another chance of snow Friday night and Saturday. At press time, no accumulation levels had not been set.
