Former Hoopeston employee charged with theft of money

A former Hoopeston city worker has been charged with theft in connection with a report of missing city funds.

On April 4, a complaint was filed against Elena M. Smith, 29, of Hoopeston, charging her with theft over \$300, a Class 3 felony.

She is scheduled to be arraigned on the charge at 1 p.m. April 25 in Vermilion County Circuit Court.

Smith was an employee in the city's water collection department since 2003. Her resignation in January was

announced at the February 6 Hoopeston City Council meeting.

An investigation into the theft, the estimated amount of which ranges from \$1,500 to \$10,000, began February 21, Hoopeston Police Chief Mark Drollinger last month.

The results of the investigation were turned over to the Vermilion County State's Attorney's office last month

Money was allegedly taken between Sept. 1, 2004 and Dec. 31, 2006.

Hoopeston man pleads to misdemeanor damage charge

A Hoopeston man arrested last year in connection with a threat against Hoopeston Area students pleaded to a lesser charge in Vermilion County Circuit Court.

Ryan C. Reed, 17, of Hoopeston, entered a blind plea Thursday to criminal damage to property, a Class A misdemeanor, in connection with an incident on October 19, 2007 in which Hoopeston Area school officials found a threat and hit list of students written on a middle school bathroom wall.

Reed was originally charged with the Class 4 felony criminal damage to government-supported property, a Class 4 felony. Reed pleaded not guilty to that charge at a preliminary hearing in December. At that hearing, Hoopeston Police Chief Mark Drollinger testified that a school custodian found the message that said a shooting would occur the week before Christmas vacation. The names of nine students, including Reed's, were included with the threat.

Drollinger testified that a handwriting expert from the Illinois State Police Crime Lab compared the message to a handwriting sample from Reed. He further testified


