State, property tax tardiness have no impact on HA budget

An unresolved state budget and late property tax bills have not tanked Hoopeston Area's finances..

At last Thursday's meeting, business director Don Dean told the school board that Friday marked the fourth payroll period without a state aid payment and without new property tax revenue.

A state budget was approved by the legislator and sent to Gov. Rod Blagojevich who said he would eliminate money for various projects across the state, which he called pork, shifting it to his statewide healthcare initiative. Legislators have said they will override the changes but Senate President Emil Jones has said he will not call for a Senate vote on Blagojevich's changes.

Meanwhile, changes in calculating property tax on farmland caused county tax bills to be late but the first installment was due Monday and Dean expects to receive a payment from the county next week.

Dean presented the board with a tentative budget, which will be on display in the superintendent's office until the budget hearing at 7:30 p.m. Thursday, Sept. 20.

Overall, the budget predicts balances will be in the black on June 30, 2008, with estimated shortfalls covered by cash on hand. "We're going to be solid," Dean said.

The district education fund will go into the 2008 fiscal year with a cash balance of \$1,502,000. Income for the fund is estimated at \$9,139,000 and expenses of \$9,529,000, resulting in a \$390,000 shortfall. The deficit includes a one-time payment of \$140,000 as the district's share of money paid for employees who opted to retire early and includes the possibility of a late state aid payment next June. "We're just assuming the worst," Dean said.

The ending balance at the end of the 2008 year is projected at \$1.1 million.

The building fund is estimated to have \$239,000 more in expenses than income, including \$139,000 for the middle school roof repair and a \$100,000 contingency. With cash on hand, Dean expects the fund to end the year with a \$22,000 balance.

The transportation fund is expected to have a \$122,000 shortfall which is "probably accurate" because the district has zero property growth.

The state is supposed to pay for 80 percent of eligible transportation expenses but often ends up paying a smaller amount, such as 80 percent of the 80 percent, leaving the rest to be paid by the district.

Despite higher costs, the fund is expected to end the year with a \$24,000 balance, down from \$146,000 on June 30 of this year.
