## New ideas cooking for Hoopeston Civic Center kitchen

The Hoopeston City Council unanimously approved hiring an architect to cook up changes in the civic center kitchen.

Charles Reifsteck, of Gorski-Reifstech, Champaign, will create a drawing updating the Hoopeston Civic Center kitchen, said Alderman Carl Ankenbrand at Tuesday night's council meeting.

Reifsteck met with Steve Laker, Vermilion County Health Department administrator, economic developer Shannon Ruh, Eugene Warner and Paul Tutwiler to discuss ways to improve the kitchen, including creating more space.

Ankenbrand said having a plan would help when soliciting grants. Also, "if people knew what we were doing, they'd probably donate also," he said.

One group who would like to help is a local sorority whose members have offered to help with fundraising and grant-writing, he said.

While the civic center kitchen will get a new look, water collection employees will be getting a new sys-

Alderman Bill Goodwine, finance committee chairman, said a Civic Systems computer system will be installed at a cost of \$50,000. Half the money will be paid this year, which will allow the system to be put on a list for spring installation, and the remainder will be paid after the system is installed.

The existing system is old and crashes, Goodwine said. It also has been sometimes inconsistent in keeping track of checks used to pay water bills.

The city will spend another \$3,500 to put its website into a format that is more easily changeable. Goodwine said the city will use CMS Made Simple, public domain software, that will allow employees to make changes to the website, saving money.

The current website was developed by Allan Simpson. Any changes to the site had to be done by him for a fee, Goodwine said. With the new system, Ruh will learn to update the site and teach other city employees to make changes, as well.

Simpson's proposal includes switching the site to the new software, training and one year of technical support.

In unrelated action, the council approved a new lease agreement with Crown Castle Communications.

Crown Castle leases space on which a tower sits on

the city slab. The existing lease would expire in 2019 but the company wanted to extend it until 2049, allowing it to sign long-term leases with providers of such things such as cell phone service.

Under the existing agreement, Hoopeston would receive \$6,000 for the first two years, \$6,600 for the next five years and \$7,200 for the next five years.

The new agreement calls for an \$8,500 "signing bonus" plus up to four percent each year in a cost-of-living agreement.

In other business, the council:

- Accepted a bid from Schuler's for perpetual care urns at Floral Hill. Schuler's bid was \$28.75 per urn and was the only bid that met specifications, said cemetery committee chairman Chuck Davis. A second bid, from Berry's Garden Center, was for \$35.95 each but did not meet specs.
- Approved participating in Illinois Municipal League's Min/Max program. With it, the city will be \$16,000 less in liability insurance but will assume \$30,000 in additional exposure. This is the fifth year the city has been part of the program and has not had to pay for the additional risk.
