Area police investigate report of shooting outside Hoopeston

Vermilion County Sheriff's Police, assisted by Hoopeston Police, investigated an unconfirmed shooting Monday morning outside the city limits. According to unsubstantiated reports, at least one person was shot, but as of noon Monday, no fatalities had been reported, according to Vermilion County

Coroner Peggy Johnson and a representative of Champaign County Coroner Duane Northrup's office.

Shortly before noon, a Vermilion County Sheriff's Deputy stood by as a car was hitched for towing on County Road 1650 East, north of County Road 2800. Sheriff's department officials, including Chief Investigator Rod Kaag, were also called to the scene.

Hoopeston Area High School and Middle School went on lockdown at about 10:30 a.m., due to the incident. Lockdown ended at about 11:20 a.m.

Hoopeston Regional Health Center was also reportedly put on lockdown.

Further details were unavailable at press time.

Three file to run for township supervisor at GOP caucus

Three people have filed to run for Grant Township Supervisor at the Republican Caucus on January 13.

Incumbent Bill Boose and challengers Megan Deck and Matthew Morgan all filed Monday morning, said Township Clerk Sharon Johnson.

Tuesday is the last day to file an intent to be a candidate for the caucus. Filings will be accepted from 1-3 p.m. at Grant Township Office, 525 S. Market.

The caucus, which will also include candidates for township trustees and road commissioner, will be held

from 6-7:30 p.m. Tuesday, Jan. 13, at the township garage.

A separate Republican caucus will held Wednesday, Jan. 14, for the Grant/Butler Multi Township Assessor's position. That caucus will be held from 6-7 p.m., also at the township garage.

Residents who either voted Republican or who did not vote in last year's primary election are eligible to vote at the caucus. Residents who voted Democrat in the primary may not vote at the caucus.
