Health center CEO announces new nursing scholarship

Harry Brockus, CEO of Hoopeston Regional Health Center, announced that the facility is offering a new scholarship for Hoopeston Area High School students who are interested in pursuing a Registered Nursing degree through Danville Area Community College. The scholarship includes tuition and fee costs up to \$10,000 for the two year program at DACC.

To be eligible for consideration of this scholarship, students will need to fill out an application, write a one page essay, and obtain a letter of recommendation from Kay Brown, the high school's guidance

counselor. The essay, to be titled "Why I will make a Great Nurse," will be reviewed by an appointed committee from Hoopeston Regional Health Center. In addition, students may have an interview with the committee as part of the selection process.

"Bowl for Kids Sake," which has traditionally been held at Lincoln Lanes in Danville, will also be held at Hoopeston's Fast Lanes.


Owner Doug Wagoner is donating his bowling alley

Vermilion County Health Department stops 'second chances' on state's smoke-free law

. There will be no more 'second chances' allowed for Vermilion County businesses that violate the state's smoke-free law, effective immediately. "For fourteen months now, we have worked to be as fair as possible and help local bars and others to adjust to the law, but now it is time for everyone to understand that the state's Smoke-free law will be enforced here in Vermilion County to its full extent," said public health administrator Steve Laker.

The Vermilion County Health Department's policy is now that once the department receives a smoking violation complaint about an establishment, that business will be given a warning letter only if they have not been identified in a previous complaint. "If a business has been previously identified as breaking the law, we will go out and inspect the site," Laker said. Until recently, the health department inspected sites only after three complaints were received about an establishment. "The warning period is over for

The change comes following passage of new legislation that clarifies the guidelines for enforcing the state's smoke-free law. Governor Pat Quinn signed the changes into law February 4, just after he took office; it was the first legislation he signed as the state's new governor. The language change sets up an administrative hearing process for violators who fail to pay their fines when they receive citations, instead of filing the citations in circuit courtsaidViolations of the smoke-free law are: \$250 for the first offense, \$500 for the second and \$2,500 for the third violation within one year.

Since January 1, 2008, Vermilion County has received 102 complaints about violations of the smoke-free law, most have been about violations at local bars. "Some of these establishments have had as many as nine complaints, making me believe they have no intention of complying with the law, but we intend to make them understand the law will be followed," Laker said.
