## Rossville board approve engineering for downtown sidewalks

ROSSVILLE—Village sidewalks are expected to be replaced thanks to a \$99,000 U.S. Department of Agriculture Rural Development grant and \$10,000 in-kind contribution from the village.

At Monday's village board meeting, trustees approved spending \$15,600 on the engineering proposal submitted by Joe Gleisner of Gleisner Engineering of Danville.

In unrelated business, the board approved the purchase of 14 radio-read water meters and related equipment from Underground Pipe and Valve, based in South Bend, Ind.

Water department chairwoman Tia Petersen said 54 meters had been returned for credit of \$2,376.

The 14 meters will replace meters that are old and need to be replaced, she said.

In other business, trustees:

Heard from Randy Dukes concerning flooding in his driveway and garage on Benton. Dukes said if the problem was not fixed soon, he would pay to have it fixed and submit a bill to the village.

City employees are expected to install a culvert in the area in the near future.

Split a vote on amending the golf cart ordinance to allow 16-year-olds to drive them in the village and also to allow night driving of carts.

Voting for the change were Dennis Barragree, Dick Queen and Petersen. Nancy Null, Mary Beth Rhodes and Chuck Cornell voted to leave the ordinance as is.

Mayor Terry Prillaman declined to break the tie, sav-

#### Fallen chief remembered

I was unable to come back to Hoopeston for the memorial of Orval Kaag, but I feel compelled to honor the memory of my fallen chief and extend my deepest sympathy to Sandy, Amy and Rod Kaag.

Orval was more than a Chief of Police for Hoopeston. He was a very kind man, who was both fair and wise in his leadership. He was a chief who embraced the people of Hoopeston like his own family, served with honor, and gave 110 percent to his officers. Trust me when I say he could put you in your place when needed. But Orval was more than a chief to me; he was a wonderful friend and a father figure. In my opinion, he took a bunch of guys and turned them to one of the best police departments in Vermilion County.

I am devastated at the loss of one of the most amazing and dear friends I have ever had in my life. My memories of Orval make me both laugh and cry. For instance, the officers on the department would put rubber bands in his pipe tobacco to make it smell like burning rubber. And I can't tell you how many times we changed his margins on his famous typewriter were he would write his famous notes to us. The notes, which often included the word "stupid," would be typed up after an incident occurred that Orval was not happy with. The notes would explain in detail everything we did wrong to generate the note. You could always tell when Orval was mad when he wrote the notes because the "i" in stupid would be punched out from him hitting the keys on the typewriter too hard. I think I had the record for the number of stupids in a row – nine.

When Orval was chief, most of the officers would go to the station the next morning after the night shift to have coffee with Orval. We would all talk about events the night before or how we could change the world. Orval enjoyed this time with his officers and he would welcome both the media and friends in to share their stories and have coffee.

During my 18 years at HPD, Orval was a great leader and I was proud to work with him. He was both my friend and a fellow officer who led his men with courage and old-fashioned grit.

I know there will be other officers who will provide outstanding service to the citizens of Hoopeston, but no
