The Maturing of Vermilion County Team, made up of elected officials, citizens and professionals from Hoopeston and Danville, will receive a Governor's Award for Unique Achievement on Wednesday at the Governor's Mansion in Springfield.

MAP cuts not solution to budget woes

I would like to discuss an issue which concerns me deeply—and should, in my opinion, concern all citizens. The Illinois legislature has proposed a significant cut to state MAP grants; this cut of \$200 million to needy students would have a damaging impact on all current students, whether they receive staid aid or not.

Low-income students are struggling financially as it is. The loss of MAP could crush any chance they have of

higher education. If colleges and universities lost all their MAP recipients, those institutions would be forced to raise tuition and housing charges and release key staff and faculty. This would negatively affect all students.

Since the 1970s, Illinois has provided student aid funds for those most in need. The Monetary Award Program has served as a policy tool to help reduce the disparity in educational attainment between students who can afford college and those who cannot.

While I appreciate governmental efforts to cut superfluous spending, MAP funding serves a vital purpose. Needy citizens, indeed all citizens, must be able to count on the state to provide assistance in a society of inevitable economic disparities.

In a nation of opportunity, no person should ever have to forego a college education just to make ends meet. Educational assistance must be one of the last state expenditures to be cut in times of economic hardship, not the first. Cutting the \$200 million to the MAP grants would be regressive and shortsighted, and I personally expect far better from this great state.

I strongly encourage everyone to contact their state legislators and let them know that Illinois citizens value higher education and won't accept the mortgaging of our future to get by in the short run.
