Hoopeston Area High School changes online homework info

Beginning January 4, 2010, there will no longer be a homework hotline link on the high school website. Instead daily homework assignments for all classes will now be available on STI Home. This change makes it easier for parents by allowing them to see daily homework assignments and current grades on the same website.

The following are instructions on the new STI Home daily assignment process:

- Go to the district website: <http://www.hoopeston.k12.il.us/>
- Click the "STI Student Info System" box.

- Under STI Home Plus –For Parents and Students, click "High School."

- Next, click Student Services & enter your student's User ID and Password.

- Finally, click a class & the "Homework" tab located at the bottom of the screen. This will show the selected class's daily assignments for the quarter. The "Grade Book" tab will show graded assignments.

H1N1 vaccine reminder

Vermilion County Health Department has scheduled additional H1N1 vaccination clinics to be held at the department's main facility, 200 South College St., Danville, on:

- Wednesday, Dec. 30 from 10 am to 3 pm
- Monday Jan. 4, 2010 from 1 pm to 6 pm
- Monday Jan. 11 from 1 pm to 4 pm
- Monday Jan. 25 from 1 pm to 4 pm
- Monday Feb. 1 from 1 pm to 6 pm

These vaccines are free. Children under age 18 must be accompanied by a parent. Pregnant and breastfeeding women are required to bring a signed order from their physicians. Legal guardians of foster children must provide a signed consent from DCFS. Parents are reminded that children under 10 who have had their first vaccination need a second vaccination 28 or more days after the first to have full immunity to the H1N1 virus.

Food for fines


Hoopeston Public Library is holding its annual Food for Fines program during December. The library will accept nonperishable food and paper products. Each item counts as \$1 towards fines only.
