Dignitaries remember fallen, those serving during ceremony

Hundreds of area residents gathered Monday to honor those who gave all - and those still giving - during the annual Memorial Day ceremony at Floral Hill Cemetery.

Keynote speaker Ed Layden Jr., an Army veteran of Viet Nam, remembered those who died while serving, including his uncle, Ted Layden who died en route to France in World War I, as well as two classmates, Joe Kelnhofer and Bill Gooden, who died in Viet Nam.

Mayor Bill Crusinberry told the audience that "freedom is not free" and urged everyone to thank a

soldier for their service.

The ceremony also included prayers by the Rev. Dustin Wells of Prairie Green Church of Christ and patriotic musical selections by the Hoopeston Area High School band.
