## Model A aficionados stop in Hoopeston during road trip

Approximately 20 Model A Fords aayoooga'd through McFerren Park Friday.

Residents, whose ages spanned from toddler to senior citizens, were at the park to welcome the vintage vehicles and their owners - all members of the A's R Us Model A Ford Club based in Homewood.

Expected at about 2 p.m., the Model Ts ran about an hour late, due to planned stops in Wichert, St. Anne, Papineau, Watseka and Milford, and a mechanical problem with one of the vehicles.

Hoopeston police stopped northbound traffic on Route 1 (the Dixie Highway) to allow members to remain together as they turned onto Penn Street to enter the park. There, caravan members were greeted by members of the Hoopeston Historical Society and Chamber of Com-

merce. A vanload of Hoopeston Community Memorial Nursing Home residents and others also turned out to welcome the group.

At the park, Jean Minick gave each person a packet of corn soap, compliments of Richard Layden. The group saw the Hubbard Trail marker and posed for pictures at the metal cornstalk sculpture and planned a short trip to the site of the former POW camp in Hoopeston before heading south to Rossville, and finally, Danville.

Club members were recreating an October 1915 trip when a Model A motorcade drove the Dixie from Chicago to Danville, then on to Miami.
