Water report details problem already fixed

Hoopeston residents are expected to get a notice in Tuesday's mail about a violation of an EPA regulation concerning city water.

The notice informs residents that coliform bacteria were found in three of 11 water samples taken throughout Hoopeston in September. EPA standards allow one sample per month/5 percent of samples to contain the microbes.

The EPA does not issue a boil order for coliform bacteria, which are not harmful but may indicate a potential problem with harmful bacteria such as E-Coli.

No harmful bacteria were found, said Steve Baker, water superintendent.

Sample sites were cleaned, chlorinated and flushed, and retested. Those samples - and ones taken this month - were all negative for the microbe.

Under EPA regulations, the public must be informed of the violation even though it has been remedied.
