**Vermilion County school districts seek to add 1% sales tax**

A one percent sales tax being discussed by county schools could provide as much as \$400,000 a year to the Hoopeston Area district.

At Thursday's school board meeting, Supt. Hank Hornbeck discussed the idea of the tax, which, if approved by half of county schools, would be placed on the November ballot.

Hornbeck said the sales tax was a better revenue source than property taxes, adding that some schools receiving sales tax income stopped levying property taxes.

The idea of a sales tax comes from the state legislature's 2007 offer of new way for schools to raise money

for maintaining and improving facilities. Money can also be used for increased security systems, improved technology, updating buildings or even constructing a new school.


While Hoopeston Area has no debt, other county districts are experiencing financial problems. The board is expected to vote on supporting the tax proposal at its April meeting.

In other business, the board unanimously approved a policy for dual credits. The policy, which excludes College Express, was presented last month and, beginning next year, allows students to take classes at the DACC Higher Learning Center in Hoopeston. Seniors with a grade point average of 3.0 would be allowed to take a maximum of two credit courses per semester, outside of regular school hours. Juniors with a GPA of 3.4 would be allowed to take one credit course per semester.

Beginning with the class of 2017, seniors with at least a 3.4 GPA may take dual credit courses at the DACC campus during the school day.


Under the proposal, such students must have taken advanced placement English III and be enrolled in another advanced course.

Seniors must be enrolled at Hoopeston Area for at least four periods each semester, enrolled in government, English IV, PE and another elective, with at least one being an advanced placement course.

Additional requirements include students involved in extracurricular activity providing a weekly grade report to the office from the DACC instructor, for purposes of eligibility.
