# Hoopeston Area board approves closing Honeywell School

A motion to close Honeywell Grade School after the 2016-17 year was slow in coming at Thursday's Hoopeston Area School Board meeting.

Board president Russ Walder read the action item, seeking a member to make the motion, finally asking Mark Schaumburg, building and grounds committee chairman, if he would do so.

With a motion by Schaumburg and a second by Lisa Leigh, the board voted unanimously to close the building after the coming school year.

The building and grounds committee has studied the issue for many months, announcing at a May 31 public forum that members would recommend the school be closed.

Several reasons were cited for the closing, including declining enrollment; the cost of updating the building. erected in 1927; and cost savings on salaries for a principal, custodian, secretary and cafeteria workers, estimated at \$253,000.

Honeywell students will be moved to John Greer, which will house third through fifth grade. Sixth grade students, who currently go to John Greer, will move to Hoopeston Area Middle School.

During the course of this year, officials will work out details of the transition plan, such as how to shuttle students who currently ride buses from Honeywell to other grade centers.

As for the structure, if a sustainable use for the building is not found, officials plan to demolish it rather than leave it to decay in its residential neighborhood.

In unrelated business, the board heard from Jim Helton, member of the Illinois Association of School Boards (IASB) regarding a planned search for a superintendent to replace Hank Hornbeck, who will retire in 2017.

Shelton told the board that it needs to make decisions.

like dates when the board will be available to interview candidates and the hiring date of the new superintendent.

Also, board members and other district staff, along with the community, will be asked for input on what qualities the board should look for in a new leader.

The board will meet in special session at 7 p.m. Monday to meet again with Helton to finalize some details of the superintendent search.

In other business, the board:

- Approved paying \$7,400 to the IASB for the superintendent search.
- Approved membership in the IASB, with annual dues of \$4,120.
- Approved student policy manuals for Maple, Honeywell, John Greer and the middle school.
- Heard from Hornbeck that after more than three years. the district has a teacher evaluation instrument that includes both an updated professional practice component and the addition of student growth information.
- Heard from John Greer Principal Dan Walder that former student Adam Sinn donated money to the school in honor of Margaret Mulcahey, who retired in May after serving 40 years as an educator in the area. She tutored Sinn when he was in school.

The \$10,000 donation will be used for the school's library, Walder said.

• Approved transfers of Keli Egan from kindergarten teacher to third grade teacher; John Klaber from middle school science teacher to middle school student services coordinator; Tom Sage from high school English to high school history; Tina Ailey from third grade teacher to fourth grade teacher; and Heather Cloud from middle school personal aide to Maple classroom aide.

All will be effective August 18.


