**City council expands liquor licenses, fees, categories**

Heftier fees, more licenses and new categories for liquor sales were approved by Hoopeston aldermen last week.

Mayor Bill Crusinberry proposed the changes, which include the following categories and fees:

**Class A:** allows retail sale for consumption on site and package sales. The annual license is \$1,000. The number of licenses was increased from five to no more than 10.

**Class AA:** For package sales only, the number of licenses was increased to 10, up from two. The fee, at \$850, was raised to \$1,000.

**Class AAA:** allows alcohol to be served at table, pri-

marily with food, but not at a bar or counter. The \$1,000 fee remains the same; six licenses will be available, up from three.

**Class B:** allows package sales of beer and wine. The fee was increased from \$550 to \$650. The number of licenses increased from two to five.

**Class BB:** allows beer and wine sales for on-premises consumption. The number of licenses was set at five, with a fee of \$650.

**Club license:** the fee was increased from \$450 to \$850. The number of club licenses is not limited.

**Special event license:** also unlimited in number, these licenses are for events held outside of liquor establishments and are available to current license holders or qualifying groups in the city. The fee remains unchanged, at \$100 for the first day, \$50 for the second, and \$25 per each additional day, up to seven total.

Crusinberry also requested the creation of two new categories, which are:

**Class TH:** created for theaters, it allows the serving of alcohol incidental to movies or live performances. The annual fee is \$100 and two licenses were approved.

**Class WT:** allows for wine samples to be served at 2

oz. per sample. The fee is \$25 per event or \$100 annually for up to six events.

With more licenses, those who previously requested one are expected to apply and be licensed. Casey's General Store and Hoopeston Marathon have requested upgrades, while Hoopeston IGA has requested a license.

Some aldermen suggested an unlimited number of licenses but Crusinberry said city attorney Andrew Mudd suggested caps on the categories.

Ald. Lourdine Florek said the council would not be doing its duty by allowing unlimited licenses, saying having to revisit the issue allows tighter control on the issue. "It's easier to keep control than it is to get it back," she said.

The increased numbers will allow for growth in both package sales and on-premises consumption, Crusinberry said, showcasing the theater licenses, which he wanted to create to help the theater. He cited Save the Lorraine Foundation's efforts to bring the Lorraine back to life. "They're achieving their dream," he said.

While the licenses are available for both the Lorraine and Little Lorraine, they won't be used quickly. "The board has not voted to request one at this time," said Ald. Alex Houmes, also vice president of Save the Lorraine Foundation.

Alderman Bill Goodwine questioned the need for so many licenses, saying he was "kind of shocked" that 10 packaged liquor licenses were created. "That's one for every 500 people, he said, some of whom are children."

Ald. Chad Yaden said Hoopeston needs to be forward-thinking. When a potential business owner asks about a liquor license, "it helps the business if we can say 'yes' right away," he said.

Goodwine was not deterred, saying the increased licenses would make it more difficult for the liquor commissioner—who is the sitting mayor of the city—to turn down requests. How does the liquor commissioner say yes to Mary Jane and no to Tom Smith? It's putting ourselves or the mayor in a position to say yes" to someone who perhaps should not have a license. Ten package liquor stores in Hoopeston - that's ridiculous."

In the end, Goodwine voted "nope" and was joined in the nay category by Ald. Brandon Hamilton. Voting for were Yaden, Florek, Houmes, Carl Ankenbrand, Bill McElhaney and Ryan Anderson.
