

#### HA board names Marc Campbell new high school principal

**CAMPBELL** 

A new principal has been named for Hoopeston Area High School.

Marc Campbell, 45, was introduced at Thursday's Hoopeston Area school board meeting.

Campbell was hired with a one-year contract at \$94,000 and will begin his duties July 1. He replaces Larry Maynard, who resigned to become superintendent at Potomac.

Campbell, who currently lives in Plainfield, has most recently served as principal of Leman

Middle School in West Chicago, a position he has held since 2014. Previous to that, he served as assistant principal at Heritage Grove Middle School in Plainfield.

Campbell graduated from Northern Illinois University with a bachelor's degree in accountancy. He then earned a master's degree in teaching from the University of Aurora and an additional master's in educational administration from Governor's State University in University Park. He is currently completing a doctorate in educational leadership at Aurora University.

A Bourbonnais native, Campbell and his wife, Julie, have two children, Matthew and Anna. In his free time, he enjoys golfing, fishing and motorcycle riding. "I'm very excited to becoming part of the Hoopeston community and look forward to serving the students, staff and families," he said.

In other personnel matters, the board:

• Voted to eliminate the high school dean of students position, replacing it with student support services coordinators Mary Johnson and Michelle White. White had previously taught fifth grade at John Greer.

Michl Kearney, who had been the dean of students, was hired as the district's new athletic director and high school PE teacher.

• Hired Suzanne Boyer, Student Leadership Club spon-

sor at John Greer; Ashley Beauvois, high school drama/musical sponsor; Kelsey Cappellano, eighth grade math teacher: Jessica Burke, high school English teacher; Kristin Powell, fifth grade teacher; and Megan Collins, sixth grade teacher.

- Approved resignations of Mara Sutton, personal aide, and Rebecca Olson, high school English teacher, both effective June 1; and Dave Jacobs, high school PE teacher and head football coach, effective June 5.
- Approved Trey Stille as head coach of the Hoopeston Area/Schlarman Academy/Armstrong-Potomac football team. Stille had been an assistant coach for the program.
- Approved reducing Ashley Gondzur to half stipend as high school student council sponsor. Dylan Swank will become the co-advisor at half the stipend rate.
- Approved Bailey Crose as high school boys' basketball team volunteer, effective May 30.
- Approved transfers of Jill Gooding from sixth grade to fourth grade; and Diana Judy from middle school assistant student council advisor to head advisor.

In other business, the board heard from community liaison Amy Linares about a district mentoring plan, which will pair third-to fifth-grade students with volunteer mentors from the community. Mentors will meet with students weekly during lunch or recess throughout the students' school careers.

Those willing to be mentors must undergo background checks and be approved by the board, although to save time, initial administrator approval may be given once a background check is completed.

A one-hour training session will be conducted before beginning the program.


