Petitions may be circulated beginning September 18, 2018. Petitions must be filed with the Vermilion County Clerk beginning Monday, Dec. 10 at 8 a. m. through Monday, Dec. 17 by 5 p. m.

Offices to be elected at the election include School Board or Regional Board of School Trustees and local city/village mayor/president, clerk, treasurer and alderman/commissioners/trustees; park district commissioners; public library district and/or township library trustees; regional board of school trustees; school board members; community college trustees; township land commissioners; and fire protection district trustees.
