California quake shakes up local residents

Some local residents were jolted by news of Monday's California earthquake.

Hoopeston residents who have family members in California said they were shaken by the news at least until they heard from their loved ones.

Betty Drollinger said she heard from daughter Sandy Boardman while the quake was going on. "She called from a car phone," Drollinger said.

Boardman and her husband, Greg, owners the Lorraine Theatre, are no strangers to earthquakes, having lived in California for several years. But this one was different.

"(Sandy) said it was the worst one she'd ever been in," Drollinger said. "She said it rolled and rolled. She was pretty upset."

Drollinger said the couple moved to Pasadena from Acton, which turned out to be a lucky move. "If they'd been living in Acton (Greg) would've been heading on that Route 5 about that time."

Part of Route 5 was demolished in the quake.

The earthquake, which measured 6.6 on the Richter scale, came as no surprise to Darrin Barker, according to his mother, Mrs. Donald Barker.

"He aid he knew something was coming because they'd been having quivers the last two weeks," she said.

Barker, who lives in Thousand Oaks, reported strong aftershocks, including one at 7:30 p.m. Monday that was over 5.0 on the Richter scale. "He said they felt aftershocks all day long," Mrs. Barker said.

One former resident was slightly injured after the quake, according to his father.

Joe Coon cut his foot on glass which broke after the quake, then was further injured when he tripped over a stereo that had fallen, said his father, Larry Coon.

The younger Coon did not seek medical attention, however. "He said he really cut his foot bad," Mr. Coon said, "but there's people who need medical help more than him, so he just bandaged it up himself."

Coon, who was in Hoopeston at Christmas time, could not wait to get back to California, his father said. "When I called him (Monday) he said he wished he'd stayed home a couple more weeks," Mr. Coon said.

All former residents living in California reported slight damage to their dwellings, including broken glass from pictures falling from walls, and slight cracks in walls from the quake.

Newest alderman plans united approach to problems

Being a representative of the fourth ward is important, he said. "We need someone up here for

sure," he said. "This is one of the largest wards in the town."

Blackwell has been employed at FMC for the past seven years. He and his wife, Marsha, have three children, Lori Montez of Cheneyville, Robin Regan of Birdstown, Tenn., and Jeremy, at home.

He will be the chairman of the civic and ambulance committees and a member of the police committee.

His term expires in 1995.
