# Liquor license request gets few, mixed reviews

Members of the Hoopeston city council are expected to vote tonight on whether to issue a third packaged liquor license - an issue most residents have been quiet about.

Aldermen surveyed Monday said they have had few comments on the issue. And comments which

have been made have been a mixed bag of those in favor of and against creating the license.

The issue arose at the April 5 council meeting, when Alan Reece requested a third packaged liquor license be created.

Reece would like to open a packaged liquor store on Route 9, somewhere between Convenient Mart and Route I.

Reese presented plans for his proposed store to the council, which tabled the issue for further study.

Alderman said they have received few comments from constituents on the proposal.

"I've had a few," said Drew Allen, fourth ward alderman. "I think I've gotten five calls. Most of the ones I've gotten have been kind of negative."

Allen said two callers said Hoopeston does not need a third packaged liquor store and were concerned about crime, "especially on Friday and Saturday nights." The constituents said a city of Hoopeston's size does not need 11 liquor-selling establishments, he added.

> Second ward alderman John Haughee said comments he has received have been mostly favorable, except comments made by one person with a vested interest in the issue.

In the first ward, alderman Wes Dazey said he "hasn't heard a word. Nobody's called me. I guess they want it or something or they'd be hollering."

Dazey added he received one call on the issue. That caller "wasn't against it."

Bill Goodwine, representing ward four, said he received only one comment about the proposed license. "That person was kind of neutral," Goodwine said. "He called about something else."

"I'd pretty much made up my mind when I heard it that night," Allen said. Crime associated with alcohol was one factor Allen considered. "I think we've got enough of that as it is," he said.

Goodwine, Dazey and Haughee are still undecided.

"I'm on the fence at the moment," Goodwine admitted, saying he is considering the possible effect on crime statistics, as well as the economics.

Haughee admitted he has not come to "a real solid decision. I have not genuinely made a decision even yet."

For Haughee, the decision will include not only considerations of crime and economics, but of

Reece, as well.

"I taught that young man and I was always impressed by his maturity," Haughee said. "I think he has a lot of character. That's probably what makes my mind evaluate carefully."

Even if aldermen create a third license, it will be up to Mayor Bob Ault to decide who, if anyone, will get it.

If the license is created, Ault, as the city's liquor commissioner, could grant it to Reece, or someone else who applies. He could also decide not to grant the license to anyone.

The two existing packaged liquor licenses are held by Ted's Home Beverage and Hook's Drug Store.
