Police officers pleased with Catron trial verdict

The conviction Wednesday of Dennis Catron on six counts of molesting a young boy is very satisfying to Hoopeston Police Department officers involved in the case.

"I'm very pleased with the verdict," said Sgt. Danny Danner, investigating officer on the case. "Officer Moyer and I put in some long, hard hours on this case."

Moyer, too, was pleased. "I was ecstatic about the verdict." he said. "The system finally worked. We've been waiting three long years for this."

Catron was convicted Wednesday of molesting a then-13-year-old Ludlow boy. Three of the six counts were from Champaign County. The other three were in Vermilion County.

The verdict came as a surprise to Moyer. "I thought he'd be convicted on one or two of the charges," he said. "I didn't think all six would

The conviction was a joint effort between the Hoopeston police and the Vermilion and Champaign county police departments, Moyer said, adding that without the county departments, "we might not have gotten all six convictions."

Danner also credits the outcome to the victim.

now 16. "Without him, this conviction would have been impossible," he said. "He was the one who wanted to go forward with this."

The officers were not the only ones happy with Wednesday's verdict. Danner and Moyer reported that after the verdicts were read on the six counts. the boy's family members hugged the officers and thanked them for their efforts. "This is the first time a victim has ever said thank you," Moyer

Danner called the trial "emotionally draining." saying that for the first time in his 19 years of police work, Wednesday was the first time "any emotion came out."

Officers said the case was investigated "by the book." That effort was appreciated not only by the boy's family, but also by defense attorney David Ryan of Danville. "He congratulated both of us on our professionalism," Moyer said.

Danner said the entire department participated in the investigation, putting in over 100 man hours on the case.

Catron was tried in absentia and is believed to be in Thailand. He faces a maximum of 30 years in prison.
