# Remaining C&S claimants to receive payment

SPRINGFIELD—The Illinois Department of Agriculture on Wednesday issued checks totaling \$2,787.072 to the remaining 82 grain claimants against C&S Grain Co., Inc.

The checks represent the undisputed portion of individuals' grain claims.

Ag director Becky Doyle said checks were issued after an agreement between the department, C&S and the Attorney General's office was signed Wednesday, allowing the department to pay the agreed minimum due claimants.

"I wish we could pay today the full amount approved during claims hearings held last February, but that is not legally possible until the complaint C&S filed in court is settled," Doyle said.

On May 10, C&S filed complaints against the claimants for judicial review and stay. In most cases, company representative argue claimants are owed less money that the state's hearings officer has determined they are due.

Wednesday's payment bring the total paid to

claimants against C&S to \$7,871,018. According to ag department records, another \$319,752 is due to complete payment of eligible grain claims, pending approval by the court.

The department is paying 100 percent of losses to eligible claimants who have proof of grain in storage. Those who sold grain to C&S but did not receive payment will recoup 85 percent of their losses, up to a maximum of \$100,000.

Proceeds from sale of grain at the company's five facilities are expected to fall at least \$182,846 short of the amount needed to pay all eligible claims according to state grain laws. The shortfall will be paid from the Illinois Grain Insurance Fund, financed by grain dealers and warehousemen statewide.

C&S president Steve Syfrett surrendered the company's grain dealer and warehouse licenses Dec. 13.

The company operated facilities in Alvin, East Lynn, Fountain Creek, Henning and Wellington.

class, Harden said. Baccalaureate is not sponsored by the school because of legal rulings barring schools from sponsoring religious activities.




