## Stockland man dies, two injured in two-vehicle accident

A Stockland man died and two people were injured in an accident Thursday night near Milford. James Ace Allen, 33, died as a result of injuries sustained in the accident.

Injured were Randy Burhmester, 24, driver of the other vehicle, and Tracy Marcum, 20, a passenger in the Buhrmester vehicle.

Buhrmester was transferred from Iroquois Memorial Hospital to Peoria, where he was listed in fair condition.

Marcum was taken to Iroquois Memorial Hospital, where she was kept for overnight observation, according to reports from the Iroquois County sheriff's department.

The accident occurred at about 9:24 p.m. Thursday, ¾-mile east of Milford on county road 950 North.

The Allen vehicle, a 1980 Chevy Luv pickup, was eastbound towards Stockland when the vehicle left the road, entering the south ditch. As it re-entered the road, it was stuck broadside by the Buhrmester vehicle, a 1973 Chevrolet Camaro.

Buhrmester was westbound towards Milford.

Allen was pronounced dead 90 minutes after the accident.

Stockland fire and ambulance and Milford fire and ambulance assisted the Iroquois County sheriff's department.
