Hoopeston man requests jury trial on shooting charges

A Hoopeston man charged in the May 24 shooting of another local man has requested a jury trial.

Terry E. Sage, of 110 N. Market, requested the jury trial at a preliminary hearing Thursday, said Sgt. Steve Bane of the Hoopeston police department.

Bane said he testified at the hearing that Sage allegedly admitted shooting Donald H. Bruce, 29, of 313 N. Seventh Ave., in the back left shoulder. He further testified than a woman at the scene pointed Sage out as the gunman.

Police then confiscated a .22 caliber rifle which they allege was used in the shooting.

The preliminary hearing was to determine if

enough evidence was available to continue with a trial. A pretrial conference was set for July 1. A trial date is expected to be set at that conference.

Sage, charged with armed violence and aggravated battery with a firearm, both Class X felonies, and aggravated battery, a Class 3 felony.

He was taken to the Public Safety Building, after the shooting, where he was held on \$75,000 bond. Sage was released June 8, after bail was lowered to \$25,000.

Police have unofficially ended an investigation into a reported second person with a gun at the scene because witnesses were unable to identify him.


