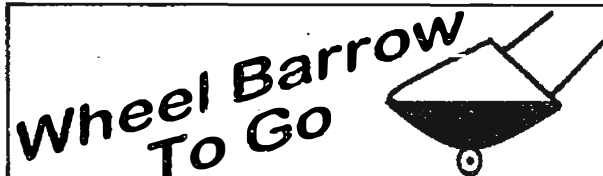

## Business owners blast rezoning request on city's northwest side

Business owners and residents are choosing sides before a scheduled Hoopeston planning commission meeting Monday.

The commission is expected to rule on a petition asking that the 200 blocks of North Ninth and Tenth avenues and West Seminary on Hoopeston's northwest side be rezoned from heavy industrial to multiple family residential.

And if Tuesday's city council meeting was any indication, attendance at the meeting will be greater than usual.

Approximately eight people, representing three businesses in the area, attended the council meeting, questioning the move to rezone.

"How can people petition to have property rezoned that they don't even own," asked Glenn Hackney, owner of a repair shop in the area.

Another business owner and resident, Martin Yetsky, questioned why the petition had 21 signatures when the area has only eight houses.

## Auxiliary police on foot patrols throughout Hoopeston

Areas with reports of high crime are receiving extra patrols, thanks to Hoopeston auxiliary police officers.

Auxiliary officers are walking beats at McFerrer Park, Parkview Court and the downtown area, said Mayor Bob Ault.

Patrols began last week and are "strictly for public relations," Ault said.

Auxiliary officers will "find out what's going on out there," by talking with residents about their concerns and problems, Ault said.

Officers are then to pass the information on to

Hackney told the council that before opening his business, he talked with Mayor Bob Ault and city attorney Calvin Hultquist about his plans. "They affirmed to me that there would be no problem, and that's the way I expect it to stay," Hackney said. "I just want to go forward with my business and get on with my life."

Another issue is what will happen to existing businesses should the owners decide to sell them.

According to city ordinance, existing businesses will be allowed to continue even if the area is rezoned. However, should businesses be sold, the property would fall under residential zoning. New owners would then have to petition the planning commission for a zoning variance.

The planning commission will make a recommendation on the issue, which will then go to the full council for a vote at its Aug. 16 meeting.

Monday's planning commission meeting begins at 4:15 at city hall.

Ault, who will analyze the information.

Although auxiliary officers are authorized to make arrests, Ault said they have been instructed to call police officers if they see crimes being committed.

The auxiliary officers are patrolling on a volunteer basis and have no set schedule. "People won't be able to tell their patterns," Ault said.

The patrols are expected to be a long-term effort, one that is already seeing positive results.

Since foot patrols have started, Ault said, vandalism at the city's mini park has decreased.

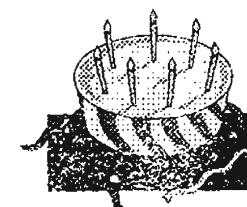
