## Who is really to blame for vandalism in Hoopeston?

A piece I read recently on the vandalism taking place in Hoopeston issued an interesting premise - that the city and police should do something.

The piece pointed out that the city council has not addressed the issue at recent meetings and that a nine-man police force should be able to DO SOMETHING about the problem.

I disagree with that premise for several reasons.

First, there really is no need for the council to discuss the issue. All they can do is tell police to step up patrols, and since acts of vandalism are occurring across the city, finding the guilty punks would be difficult.

Second, while a nine-man police force is sufficient to deal with most aspects of crime, again, the randomness of the vandalism makes it impossible for officers to be in all places at all times.

I've yet to figure out how two or three officers per shift can watch the hundreds of cars that are

Third, by blaming city and police officials, the truly guilty parties are let off the hook.

It's not officials who are out spraying cars and police are not scratching vehicles just to make more paperwork for themselves.

The guilty parties are the kids who persist in damaging others' property for kicks and their parents for not giving a rat's rear what their kids do.

It's difficult to think of youngsters performing these activities. It would be nicer to think of them as they were portraved in Leave It to Beaver, but that's not the way things are anymore.

To let those who are guilty shirk their responsibilities is pure folly.

And to blame those who aren't guilty is shortsighted.

But these days, with a trend away from personal responsibility, that's all too normal.


