

Stockland Fire Dept. to benefit from PlayCrafters performance

The Hoopeston PlayCrafters will perform five comedy sketches Sunday, guaranteed to have the audience in stitches.

But that's all right, because there will be plenty of emergency medical technicians in the audience.

The PlayCrafters are performing "Comedy Times Five" as a dessert theater benefit for the Stockland Fire Department.

The performance, at 3 p.m. Sunday in the Stockland gymnasium, will include "The Case of the Frustrated Corpse," "Life On Other Planets," "The Crown Game," written by John Parkinson, "No Garden This Year," and "PMS Ain't Nothing," written by David Lohnes.

Russell Peak is the director for the benefit, with lighting and sound by Laurie Peak. The sketches are produced by Tony Hasbargen.

Tickets for the benefit are \$4 for adults and \$2 for children 10 and younger.

Proceeds will be used to help purchase a defibrillator for Stockland Fire Department EMTs, said Linda Hancock.

Hancock, an EMT, worked with PlayCrafters member Tony Hasbargen to arrange the benefit. "We were trying to think of different things for fundraisers," she said. "I heard Tony on the radio when (PlayCrafters) were getting started and called him," she said.

Beside entertainment, the benefit will also feature Christmas desserts made by the firemen's wives, Hancock said.

Firemen will arrange seating for 200 at the performance, but if more show up, that will be no problem. "We've always got the bleachers, so we could seat 200 more," Hancock said.

The department needs \$7,000 to purchase a defibrillator, a machine which shocks a patient's heart during cardiac arrest, Hancock said.

A fundraiser in October, plus matching funds from Modern Woodman, netted \$4,000 toward the purchase price.

Hancock said the defibrillator is needed because Stockland is 20 minutes from either Hoopeston's or Watseka's hospitals. "Your chances of survival are greatly increased (with the defibrillator)," she said. "This would be an asset to the community."


