Deputy probation officer arrested in death of local man

A Hoopeston man was killed after being struck by a car driven by Vermilion county's deputy chief probation officer.

James E. "Pokey" Wallace, 38, of Hoopeston, died Friday night after he was hit by a vehicle driven by Edward A. Miller, 46, of Oakwood.

According to police reports, the accident happened about 9:20 p.m. Friday. Miller was westbound on U.S. 150, just east of Batestown Road west of Danville when he allegedly struck Wallace, who was walking east against traffic in the middle of the westbound driving lane.

Wallace, who reportedly sustained massive head injuries, was pronounced dead at 9:21 p.m. by

Peggy Johnson, Vermilion County deputy coroner.

Miller was arrested for driving under the influence of alcohol and was released on 10 percent of \$1,000 bond and his driver's license.

According to reports, Wallace was also believed to be intoxicated at the time of the accident. Toxicology tests are expected to be performed.

Since the accident, other motorists have contacted county officials to report that they nearly hit Wallace Friday night.

Funeral services for Wallace are scheduled for 1 p.m. Tuesday at the First Apostolic Church in Hoopeston.

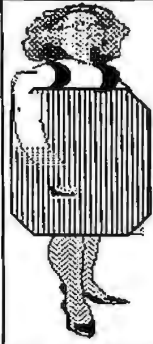

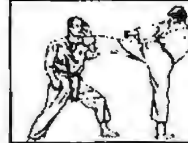

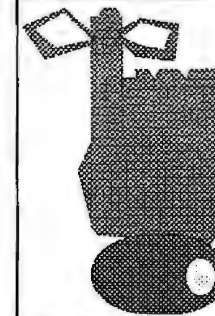
