

#### Local man heads suit against C&S Grain owner

A Hoopeston man is chairman of a committee trying to sue the owner of the bankrupt C&S Grain Co.

Russell Leigh is chairman of a creditors' committee, formed to look after the interests of unsecured creditors in the C&S bankruptcy.

The committee represents approximately 250 such creditors, mostly farmers and some vendors, Leigh said.

In a suit filed last week, the committee is requesting that action be taken against Steve Syfrett. C&S owner, to recoup money the group says he owes the company.

Federal Bankruptcy Judge Gerald Fines will

hear the request March 23.

The suit alleges that Syfrett paid several expenditures - including payroll, rent and utilities on C&S facilities - without prior approval of the bankruptcy court, Leigh said.

"We're asking that that money be put back into the pot, so to speak," Leigh said.

At issue is more than \$229,000 in shareholder receivables which the committee believes should be divided among creditors.

According to news reports, Syfrett disputes the amount owed, saying he paid \$210,000 of his own money and owes the company only \$19,000.

Leigh said the committee has the right to approve any reorganization plan submitted by C&S under Chapter 11 bankruptcy laws. The committee may also recommend how company assets are divided.

"None of that was done and we want to know why," he said.

C&S filed bankruptcy after the Illinois Department of Agriculture suspended its warehousing license in December 1993.
