

erance pay and health care. "In closing situations like this, you'd think they'd up the ante," he said. Under the current contract, members of the Grain Millers union will get one week of pay for every year worked, up to 25 years. "We know we'll get that," Hurt said.

Pillsbury has also set up a job center at the plant, where Job Training Partnership workers counsel company employees, Hurt said.

The company is also paying for computer classes offered through Danville Area Community College at Hoopeston Area High School. "That's a good deal, but that's it," Hurt said. Another point of contention between workers and the company is that since Pillsbury announced the plant closing, company donations to community organizations has doubled, to an estimated \$50,000.

"We think they ought to take care of their own first," Hurt said. "We are the community."

The company also announced double shifts will begin next week to build inventory prior to the closing.

Hurt said the second shift will be manned by temporary workers, which is good for local people but not for employees. "It's causing hard feelings," Hurt said. "They're getting our employees out of there faster."
