## C.A.R.E-endorsed candidate not registered to vote

A candidate endorsed by a local anti-landfill expansion group is not a registered voter.

Danny Justice, running for a two-year term in Ward 1. is not a registered voter, according to Lynn Foster, Vermilion County clerk.

Justice, one of five candidates endorsed by Citizens Against Ruining the Environment (C.A.R.E.), was not challenged when he submitted his petition to run and will remain on the ballot, Foster said.

Whether Justice will be seated on the council depends on voters and the current city council.

Should Justice garner enough votes to beat incumbent Mark Drollinger, it will be up to the council to decide whether his voting status qualifies him for a seat, said Pat Freeman of the Illinois Board of Elections.

Justice cannot legally register to vote until April 6, Freeman said. Since new council members will not be sworn in until after that date, Justice could still be sworn in, if he registers and is elected, she said.

"It will be up to the council," Freeman said. "In a situation where a candidate registers before the swearing in. I've never known anyone to be removed. I would be surprised if they removed

him."

Justice's status was discovered Thursday when a resident called Carol Flint, Grant Township supervisor. The resident received a precinct list, noticed Justice's name was not on it and called Flint, a deputy registrar and precinct committeeman, to find out why.

Flint called Foster, whose records showed Justice did not re-register when he moved from his parents' house on Scott Drive to his current residence on West Washington.

Foster said a canvass card was sent to Justice in May 1994 at his old address. The card could not legally be forwarded and was returned.

A follow-up letter was then sent, and reportedly forwarded, although Justice denies receiving it.

"I didn't get either one," Justice said. "I didn't know anything about it until (Flint) called this morning and I said 'oh-oh.'"

Attorney Joe Moore, C.A.R.E. co-counsel, said he was unaware of Justice's voting status, adding state statute mandates a candidate be "a qualified elector" of the municipality he seeks to represent.

Moore would not comment further, saying he was not part of C.A.R.E.'s selection committee. "I didn't select anybody," he said. "It's not my job."
