

The list of services which can be snatched from this service is pretty impressive.

Problem is, I can't figure out how to get there. Which goes back to the floppy.

I've got all this information on what the service will do for me, but seemingly none on how to actually access the information.

I've been working with this computer enough to know that the disk must go in drive B, but after that, I'm lost.

I suppose I could push a few buttons and see what happens, but unfortunately, I've seen what happens when I push a few buttons and don't know what I'm doing.

It's not a pretty picture.

So here I sit, poised on the on-ramp, wondering

which way to go. And I feel pretty stupid.

It's not that I'm not an intelligent woman - I am. I can figure out almost anything, as long as it's not advanced math - or computer stuff.

I am perturbed at the people who write this

stuff. They assume that everyone has a fairly good working knowledge of computers.

While I know enough to get the paper done every day, I don't know enough to do much else.

And at this rate, I never will.

I figure the analogy between these on-line services and a highway is a pretty good one for me.

With computers, as with driving, I have no sense of direction and get easily lost.

And I expect my computer to work like my car: get in it and go.

Unfortunately, it doesn't work that way.

I suppose someday I'll get the hang of this new-fangled stuff, but it's going to be a long time coming.

Other people are whizzing through this computer stuff, meeting people, learning things.

Me, I'm just roadkill on the information highway.
