### Hoopeston Area waits on Sangamon Valley decision

Hoopeston Area school officials expect to hear Friday afternoon whether they will become part of the Sangamon Valley sports conference.

The school board Thursday night approved joining the conference, but officials must wait to hear whether 11 other school boards, all meeting Thursday night, accepted the enlarged group.

If accepted, the conference will have a total of 13 teams, 12 fielding football squads, said Jim Matta, Hoopeston Area athletic director.

Teams will be divided into large and small divisions, Matta said. Large schools will include Prairie Central, Hoopeston, Paxton, Clifton, Watseka and LeRoy, which co-ops with Tri Valley, while Gibson City, Iroquois West, Blue Ridge, Milford, Rossville-Alvin and Fisher will make up the small division.

Having 12 football teams will allow conference members to meet IHSA requirements of each team playing five conference games per season, Matta said.

The Hoopeston Area board voted to go with the Sangamon Valley conference after meeting not only with that conference's officials, but also with members of the Illini Central Conference.

Hoopeston Area met with the ICC last week, but was not officially invited to join, Matta said. "It was a 'maybe you'll be invited to join' situation," he said.

While much of the maneuvering to join the conference has revolved around football, Matta said Hoopeston Area will compete in other conference sports, including baseball, basketball, girls basketball, golf, track and wrestling.

### Briefly

#### Trial set for probation official

The trial for a top county probation officer will begin June 19.

Edward A. Miller, a deputy chief probation officer, pleaded not guilty earlier this week to charges of reckless homicide and driving under the influence of alcohol.

Miller, 46, of Oakwood, was indicted by a grand jury April 19, charged in the death of James "Pokey" Wallace of Hoopeston.

Miller allegedly struck Wallace as Wallace walked along U.S. 150 near Danville. Toxicology reports showed that at the time of the accident, Wallace had a blood alcohol content of .25.

Under Illinois law, a person is legally intoxi-

cated with a level of .10 or higher.

A coroner's jury ruled Wallace's death accidental.

Miller was placed on paid administrative leave following the accident and has been on unpaid leave since the grand jury handed down its indictment.


#### Man acquitted

A rural Rossville man was acquitted on a charge of rape.

Donald E. Tweedy was found not guilty of criminal sexual assault Wednesday following a jury trial in Vermilion county court.

Tweedy had been accused of attacking a woman in 1994 in Hoopeston.
