The program is conducted in two separate classes scheduled on two different days. Divorcing parents will not be scheduled to attend the same classes.

> Since Children First is required by court order, all divorcing parents must attend.

Failure to attend the program may result in a parent being found to be in contempt of court. an offense punishable by jail.
