Treasurer reports on April interest, investments

DANVILLE—Vermilion County treasurer Sue Stine reported that for April 1995, the county has \$16.468,508.43 invested in time deposits and U.S. Treasury bonds, earning between 4.08% and 9.1%

The total of all money held by the treasurer is \$21,226,850,21.
