




#### Central blitzes Prairie Jerker conference hopes

What looked like a straight pass turned into a quarterback sneak for Hoopeston Area sports teams.

Prairie Central, voted Monday night to stay in the Cornbelt Conference, said Jim Matta, Hoopeston Area athletic director.

"We're right back where we started." Matta said Tuesday morning. "Right now, we're nowhere."

Matta said Prairie Central voted the proposal down because officials there believe the district will consolidate in the future, giving Prairie Central more than 800 students. "They felt Sangamon would ask them to leave then." Matta said. "They're probably right."

Hoopeston Area had been invited to join the Sangamon Valley conference, but the invitation hinged on whether Prairie Central would also join. Matta said.

The proposal involved 11 other schools: Prairie Central, Paxton, Clifton, Watseka, LeRoy, Gibson City, Iroquois West, Blue Ridge, Milford. Rossville-Alvin and Fisher. Schools were to be divided into large and small categories, each with six schools.

The plan would have allowed the conference to meet Illinois High School Association rules mandating five conference games per football season. Matta said.

Hoopeston Area officials also met with representatives of the Illini Central Conference, but that group did not issue an invitation to join.

Hoopeston Area has been independent since the Wauseca conference disbanded in the 1980s.

## Man roped for Milford Fun Days rodeo deception

A rural Milford man is being held in the Iroquois County jail on charges that he fraudulently sold tickets for a Milford Fun Days rodeo.

Stewart E. Williford, 42, of route 3, Milford, allegedly advertised that country music artists Clay Walker and Jeff Carson would appear at the rodeo, scheduled June 16-17.

"Although Williford may have started off with good intentions, once he realized that he could not pull this event off, he continued to sell tickets." said Iroquois County sheriff Joe Mathy. "We do not know at this time how many tickets have been sold or how much moenv is still available."

Those selling tickets are being asked to stop immediately and contact the sheriff's department.

Mathy estimated Williford needed approximately \$80,000 to hold the rodeo by paying the performers, rodeo participants and stock contrac-

Mathy alleges Williford formed the Sugar Creek Rodeo Association, then convinced Fun Days officials to schedule the two performances. Williford "made contact with Walker and Car-

son." Mathy said, but did not sign them to perform.

Williford was expected to be arraigned late Tuesday.

The Iroquois County Sheriff's Department and Milford police are continuing the investigation. Fun Days officials could not be reached for comment at press time.






