Attorney files group suit against Norplant manufacturer

A group of area women and a Hoopeston lawyer are taking on a pharmaceutical company in what attorney Calvin Hultquist called a "David and Goliath situation."

Kate Giffin, partner in Hultquist & Giffin, is representing 14 women in the law suit filed May 15 against Wyeth-Ayerst Laboratories, Inc., manufacturer of the Norplant birth control implant.

Wyeth-Ayerst is a subsidiary of American Home Products Corporation.

The suit, filed by 14 Norplant users, alleges the company failed to use reasonable care marketing, manufacturing, designing, distributing and selling the implant. The suit brings a charge of negligence and alleges the company misrepresented the possible side effects of the device and alleges a breach of warranty by the manufacturer.

The suit is not a class-action suit, although na-

tionwide, there are class action and multi-plaintiff suits pending against Wyeth-Ayerst. Hultquist & Giffin is considering asking the federal court to open the case as a class action, according to a press release from the attorneys' office.

Giffin said she became involved after several women complained they experienced severe side effects from Norplant and because the manufacturer emphasized how easy the implant is to remove when actual removal could be "exceptionally painful and complicated."

The plaintiffs in the suit are all from Vermilion and Iroquois counties. The women allege side effects including severe weight loss or gain, excessive hair loss, numbness, painful continuous menstrual cycles, nausea, headaches, mood swings, blurred vision, water retention, acne and scarring and nerve damage when the device was removed.
