



A purchaser for the local Pillsbury plant is one step closer to inking a deal for the factory and Hoopeston is closer to 50 new jobs.

The Hoopeston city council Tuesday night approved a \$100,000 revolving loan for the new company.

The company wants to remain anonymous until the deal is closed, said Bill Goodwine, chairman of the city's finance committee and member of the revolving loan committee.

The deal is expected to be closed at the end of this month.

The company's purchase hinges on whether it can secure a \$100,000 loan from the city and a \$750,000 Department of Commerce and Community Affairs loan, along with financing from "a major Chicago bank," Goodwine said.

City officials approved their portion of financing contingent on the city holding a piece of property with lagoons on it as collateral.

The dimensions of the property were not immediately available.

Goodwine said this will be the first venture for the corporation, which includes a former Pillsbury/Green Giant official.

The company plans to hire 50 employees. "These are not minimum wage jobs." Goodwine said. "These are good-paying jobs."

Pillsbury is expected to close its doors next month, costing the area nearly 200 jobs.

# Local Norplant lawsuit consolidated with 80 other suits

A lawsuit filed in Danville against the manufacturer of a birth control device will be consolidated with similar cases and transferred to Texas.

The Hoopeston law firm of Hultquist & Giffin recently filed a multi-plaintiff suit in Danville federal court against Wyeth-Ayerst Laboratories. Inc., manufacturer of the Norplant birth control implant.

Wyeth-Ayerst is a subsidiary of American Home Products. Corp.

The suit is one of six which will be combined with approximately 80 other cases. all against Wyeth-Ayerst and/or American Home Products Corp.

The consolidation will not be appealed by local attorneys. "It does make sense to consolidate the

case since it will save the taxpayers a lot of money - and we believe we will get just as fair a trial in Texas as we would in Illinois." said attorney Kate Giffin.

Fourteen Vermilion and Iroquois county women were plaintiffs in the May 15 filing. Since then, however, more area women have come forward wanting to be added to the suit.

The lawsuit alleges negligence and that side cffects of the device were misrepresented.

Plaintiffs have alleged severe side effects, including excessive weight gain, severe mood swings, excessive hair loss, numbness, painful, continuous menstrual cycles, nausea, headaches and scarring and nerve damage when the device is removed. □will meet in special session at 7 p.m. June 27 to vote on whether a proposed landfill expansion meets the needs of the intended 31-county service area.


