## C.A.R.E attorney steps down, cites conflict of interest

One of two attorneys leading the anti-landfill expansion fight has resigned from the case.

Joseph Moore, who has represented Citizens Against Ruining the Environment (C.A.R.E.) and other expansion opponents for approximately two years, resigned nearly a month ago.

Conflict with other clients of his Danville firm. Davis, Moore and Delanois, was cited as the reason for the resignation.

Moore would not comment further, saying only that "it was a forced matter. It was not something I wanted to do."

C.A.R.E. co-counsel Richard Doyle called the resignation "necessary," saying "it is not going to have any effect whatsoever" on the on-going landfill expansion fight.

"We will certainly miss his input," Doyle said, adding he will continue to represent C.A.R.E. and other opponents.

Both attorneys had represented opponents without charge, only being reimbursed for incurred expenses. If Moore had to resign, Doyle said, now is better than earlier in the fight because the planned expansion is now a "one-issue situation."

The courts have upheld that eight of nine criteria were met when the council originally approved siting for the expansion in April 1993.

The only issue which may go through the court system is whether the planned 120-acre expansion is needed in the intended 31-county service area.

On June 27, the Hoopeston city council decided in a 5-4 vote that the expansion is needed.

Doyle has 30 days from that date to file an appeal with the Illinois Pollution Control Board, but he has said opponents are willing to sit down with representatives of Illinois Landfills, Inc., owners of the Hoopeston site, to discuss possible compromises.

Despite Moore's resignation. "I know his best wishes go with us," Doyle said. "We know where Joe's heart and mind are in this issue and it will keep us buoyed as we go forward."

## City workers make Maple, South Fifth St. four-way stop

Less than 24 hours after being approved, stop signs have been put up on Maple Street at South Fifth St., making the intersection a fourway stop.

The signs were put up Thursday morning, after the Hoopeston city council approved an ordinance for the signs Wednesday night.


The signs were posted as the result of action by Hoopeston resident Jim Richards.




