Landfill issue heads back to Pollution Control Board

The clock is ticking again for a decision from the Illinois Pollution Control Board on a requested expansion of Hoopeston's landfill.

Attorney Richard Doyle, representing expansion opponents, appealed the June 27 Hoopeston city council vote granting a 120-acre expansion of the Illinois Landfills, Inc. site.

Doyle's appeal was filed Monday with the Pollution Control Board in Springfield.

The clock starts when the Chicago office receives the appeal, which is expected to arrive Wednesday, said John Cross of the Pollution Control Board.

The board has 120 days to decide whether the city council acted properly when it voted that a need for an expanded landfill exists in the planned 31-county service area, Cross said.

whether an expansion should be granted. During earlier appeals, courts ruled other criteria were met, but said the council's written decision showed a need in Hoopeston and the Vermilion County area, not the intended service area.

The appeal comes as both sides work toward a compromise on such points as the number of counties and the truck route used to the landfill.

While Doyle did not return telephone calls, Jim Van Weelden, landfill general manager, said negotiations will continue. "We are going to try to come up with something that addresses their concerns," he said. "I feel they filed their appeal to have a couple different avenues to go."

Van Weelden has not yet met with Doyle, but some contact has been made "via fax and phone." A meeting is expected to be held in the near future, he said.


