Unmade 900 telephone calls can be challenged: attorney

Let's face it, nobody likes to pay Legally the bills.

What's worse is when your bill is three or four times higher than the amount you anticipated because somebody, somehow has put the scam on you.

However frustrating being scammed may be, if you know your rights, you should not have to pay those charges.

You have the right to question any charge that appears on your telephone bill, whether it is a long distance call, collect call, third party call or

900 number call. You begin the challenge process by calling or writing your telephone company within 60 days of receiving the statement showing the charges in question.

The telephone company must respond to your inquiry within 40 days, unless the dispute is resolved before that time.

Neither your long distance company nor your local telephone service may

be disconnected if you choose to withhold payment during the time you are challenging a charge. However, you must continue to pay for all charges on your bill that are not part of the disputed amount.

company must correct the error and notify you of the correction. Your account will be credited for the amount in dispute.

If your challenge is unsuccessful, the telephone company must provide you with a written explanation of their findings. Upon your request, the telephone company will provide you with documentary evidence of why you were billed for the charges in question.

If you are not satisfied with your telephone company's decision, you may contact the Illinois Commerce Commission at (800) 524-0795 for further review.

You will have a minimum of 10 days to pay the amount in question if your challenge is unsuccessful. Remember, failure to pay the amount may be reported to a credit reporting agency or subject to collection. The telephone company may put an involuntary block preventing you from making any 900 calls.


